- The economy of Lithuania is one of the fastest growing in the world for the last decade.
- The climate in Lithuania is between maritime and continental. Average temperature in July is 23°C, and average temperature in January is -4.9°C.

ENTRY REQUIREMENTS

- Secondary education equivalent degree
- Level of English: B2 (CEFR Common European Framework of Reference for Languages) /or its equivalent IELTS 5.0.

APPLICATION FORM

Documents required for application:

- Completed Application form in English.
- Official legalised Certificate of Education including Grade Transcript (Translated in to English).
- 500-word (2 pages) Motivational Essay.
- Level of English B2 (CEFR Common European Framework of Reference for Languages) / or its equivalent IELTS 5.0.
- A notarised copy of Passport.
- Bank statement (original, not a copy) providing evidence of ability to support oneself for the duration of the studies (tuition, accommodation and living expenses, etc.) or a notarized letter of guarantee from parents/sponsors along with a Bank statement (original, not a copy).
- 3 full-colour pictures (3x4).
- Proof of paid Application Fee of 50 € (non-refundable) Application forms and all information about step-by-step application procedure you will find at www.islb.eu
